DISCUSSION:

The attached Fireworks Enforcement Task Force Summary report provides the Honorable City Council with a summary of actions taken against the use of illegal fireworks from June 15 - July 7, 2019. The Task Force was formed in response to concerns expressed by residents of Victorville on the negative effect that illegal fireworks were having on their lives and the community. The Task Force utilized a multipronged approach including public messaging designed to educate and create community awareness on the dangers of illegal fireworks, as well as neighborhood based enforcement actions. Community feedback on efforts to eliminate illegal fireworks usage was positive with a strong sentiment to increase future enforcement periods. Recommendations from the Task Force for future consideration include increasing citation fines for illegal fireworks, continued use of the anonymous online reporting tool, continuation of neighborhood based enforcement activities and making public the list of residents receiving citations. Further details on the Fireworks Enforcement Task Force activities and additional recommendations are contained in the report.

Fireworks Enforcement Task Force Summary

Illegal fireworks are a growing problem both nationally and locally. A fire caused by illegal fireworks that occurred in an LMAD on Amethyst Rd. in June 2018 threatened nearby homes. To address the issue, the City of Victorville initiated a pilot enforcement program in July 2018. A Fireworks Enforcement Task Force was again established in June 2019, expanding the pilot. The 2019 Fireworks Enforcement Task Force consisted of personnel from the City of Victorville Code Enforcement, Animal Care & Control, Fire Department, Public Works, and City Manager's office as well the Victorville Sheriff Department. This multi-department Task Force developed a strategy that included a public messaging campaign and enforcement activities. This report provides details about the Fireworks Enforcement Task Force along with results of the messaging campaign and enforcement efforts.

Legal Structure

All fireworks are illegal in the City of Victorville per (13.22.010 [Fireworks Prohibited]). Legal counsel recommended the issuance of Administrative Citations as the primary enforcement tool. Code Enforcement and Animal Care & Control Officers can issue Administrative Citations for observed code infractions. Illegal fireworks in view would be confiscated and turned over to the Victorville Fire Department for secure storage. Sheriff's deputies would be on-hand for Task Force member safety as well as managing any criminal violations.

Public Messaging

Our public messaging strategy included tactics such as press releases, social media posts, portable digital messaging signs, the City website, and the Jumbotron at the Autopark. The portable digital messaging signs were moved throughout the city to maximize message exposure.

The social media messaging campaign that occurred between June 5 and July 6 focused on the following theme areas: fireworks are illegal in the City of Victorville, the threat of fire, risk of bodily injury, the stress on pets and residents suffering from Post-Traumatic Stress Disorder (PTSD). Following are the number of posts per key message theme.

Theme of Post	No. of Posts
Fireworks are illegal	6 posts
Bodily injury	2 posts
Stress on pets	2 posts
PTSD	2 posts
Threat of fire	2 posts

Additional social media posts provided updates on fire incidents, development of an online reporting tool, and the status of enforcement efforts prior to July 4.

ZenCity, our online media analysis tool, was used to measure public sentiment and response to our social media posts. Metrics indicated that 5,065 interactions with our posts occurred. The overall sentiment was found to be:

- 11% positive
- 11% negative
- 78% neutral

Further analysis found that the Victorville community supported illegal fireworks enforcement. Strong sentiment exists in our community that supports expanded enforcement efforts.

An analysis of 272 Facebook comments indicates:

- 87% supported enforcement
- 61% sought further expansion of enforcement programs
- 6% were against enforcement

- 6% sought increased fines for illegal fireworks violations.
- Support to increase illegal fireworks enforcement efforts and increased fines for violators was expressed.

Enforcement Activities

Task force enforcement activities were conducted by both marked and unmarked Sheriff Patrol units and Fire Department vehicles. Marked units were staffed with a Deputy and Code Enforcement or Animal Control officer. Fire department personnel assisted with fireworks that were confiscated. Enforcement was conducted on the following dates:

- June 14, 15, 21, 22, 28, 29
- July 3, 4, 5, 6, 7

Task force units responded to reports of illegal fireworks made to Victorville Police Dispatch, 911 calls, online submissions, and team member observations. Reporting metrics included:

The online reporting form was viewed 2,791 times, but only 564 online reports were submitted. We will implement changes to the online form that increases a sense of anonymity to encourage more reporting next year.

A breakdown of direct time and costs associated with Task Force enforcement activities is shown.

Animal Control spent additional time in responding to loose dogs as well as in administrative follow up. These amounts do not include the City and Police Department staff time in organizing and planning the Fireworks Task Force program.

Task Force Enforcement Outcomes

The Task Force issued a total of 77 citations and deterrent contacts in 2019 with an associated dollar value of \$6,700 in fines issued. Despite promoting a fine of up to \$1,000, actual citations were issued at \$100 per citation due to a weakness verified in our Code to assess a higher amount. A breakdown is provided below:

- 67 fireworks enforcement citations
- 8 deterrent contacts
- 1 warning
- 1 noise citation

Also, deputies made two arrests during illegal fireworks enforcement activities.

Animal Control officers responded to 97 calls for loose dogs and picked up 30 of those dogs during the enforcement activity period. Animal Control estimates that 40% of the impounded dogs were returned to their owners. Dogs that were unable to be returned were placed for adoption through the Victor Valley Animal Protection League.

The 67 fireworks enforcement citations issued in 2019 are in comparison to eight (8) citations issued during the enforcement pilot program in 2018. The approved process for collecting citations fines will be followed.

A specific address reported in the online reporting tool increased issuance of citations to approximately 50%. Specific locations allowed a directed approach to enforcement.

A total of approximately 3,120 lbs. of illegal fireworks were confiscated. This includes 3,000 lbs. confiscated in April 2019.

Areas for Improvement

An After-Action Review of the 2019 Fireworks Task Force program was conducted to identify improvements for future task forces. A summary of consideration is listed below:

- Strong pro-enforcement sentiment from our community supports increasing the number of task force units.
- Start the illegal fireworks public messaging sooner.
- Add additional portable digital signage.
- Develop an illegal firework enforcement image for program branding.
- Consider producing video shorts of personal testimonials to post on social media and the city website.

- Re-design the online reporting tool to make it easier to enter an address anonymously.
- Because 50 percent of the citations issued were the direct result of the online reporting tool, this form should be used again next year. Additionally, the online reporting form should be a key focus of the public messaging campaign.
- Consider revising the City of Victorville Municipal Code to refer to statutes
 adopted by the State of California legislature for illegal firework fines. This would
 increase citations fees to \$1,000 for each offense. Fines can be used to offset
 enforcement costs and public awareness costs that are incurred as a result of
 illegal behaviors.
- Consider revising the City of Victorville Municipal Code 13.04.030 Throwing Missiles, to include illegal fireworks and establish a minimum of fine of \$1,000 per occurrence. Encourage people reporting illegal fireworks to provide more specific locations to aid our enforcement efforts.
- Consider making the list of people who are issued citations public through the City website or media.
- Monitor Craigslist and Facebook Marketplace to identify people who are advertising and selling illegal fireworks.
- Post on the City's social media outlets a thank you message to those who reported illegal fireworks.
- Identify a coordinator to capture and monitor citations, deterrents contacts, and other data elements of the enforcement program. This would be a secondary assignment of limited duration best established in the Code Division.

Summary

Illegal fireworks in the City of Victorville create dangerous conditions for fire, injury, pets, and people suffering from PTSD. Compliant residents are aware of the scope of the problem and support increased enforcement activity. Communicating the status and results of enforcement activities with the community is essential. These communications address the skepticism that has been publicly expressed and promote transparency and accountability to the community. Considerations to improve future enforcement activities have been identified. Implementation of these considerations will enhance the effectiveness and efficiency of future campaigns. The goal of the Fireworks Enforcement Task Force remains to maintain a healthy, safe, and comfortable lifestyle for all Victorville residents.






